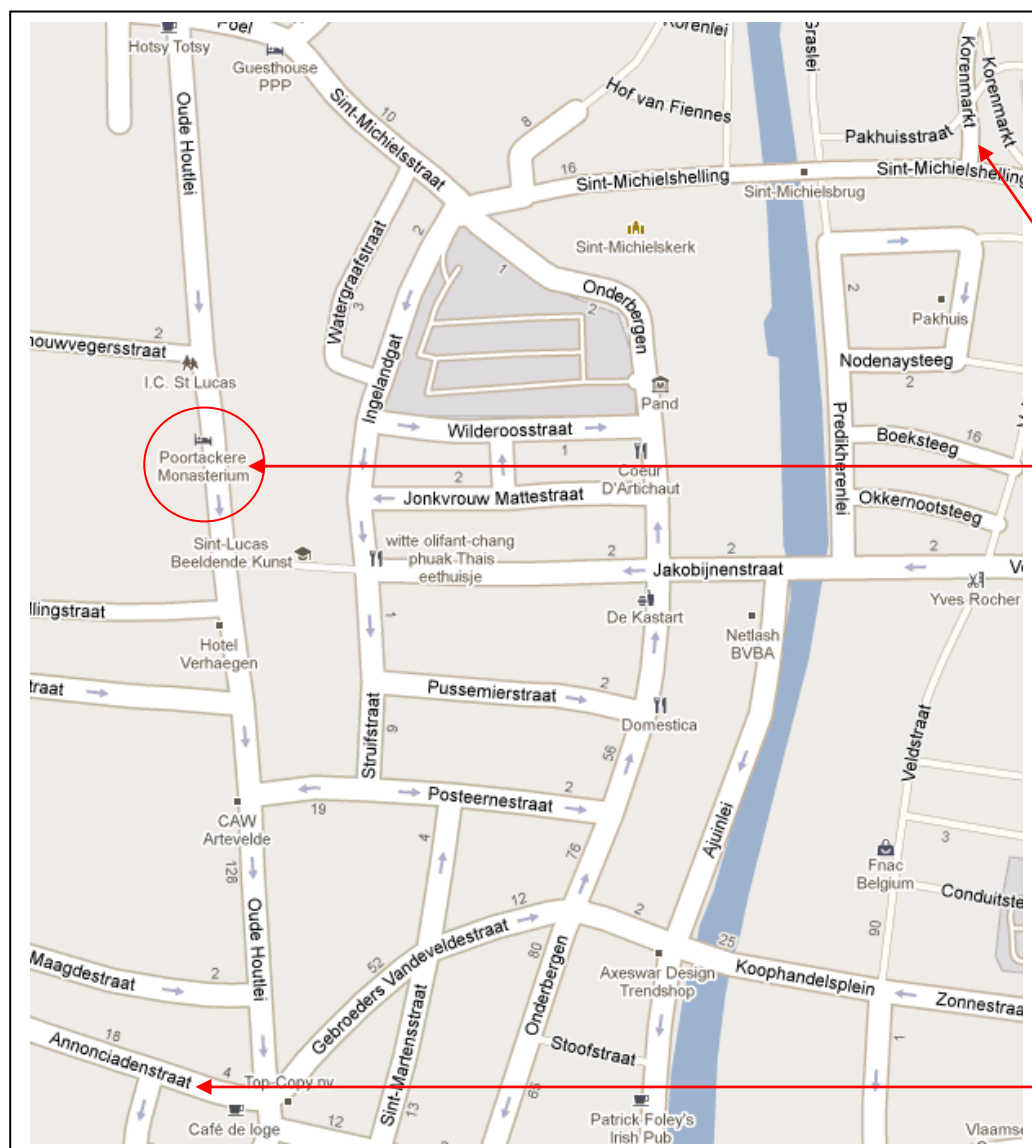

By Tram from Main Station (“Gent-Sint-Pieters”)

Line 21 (direction Melle Leeuw) or 22 (direction DC Gentbrugge): Get off at the stop “Annonciadenstraat” or “Gebroeders Van de Veldestraat”. At the crossing point of the Annonciadenstraat and the Gebroeders Van de Veldestraat, you take the street in between the two of them = Oude Houtlei.
