Restorative justice along the Silk Road: Comparative lessons from Europe to Asia on reconciliation, forgiveness and peace

In this lecture, Prof. Braithwaite will discuss how restorative justice perspectives that have travelled following the Silk Road, today compare. To do this he will discuss Eastern, Middle Eastern and European perspectives, by focusing on (respectively) China, Iran, and Kosovo and Northern Ireland, as well as other points along the Silk Road. He will also discuss how Republican ideas have and still travel along the same Silk Road, leaving the countries along the Road (including Turkey) influenced by both Eastern and Western ideas on how to create a republic. He will propose a social democratic hybrid model of governance, which by embracing principles rooted in seemingly contradictory approaches (republicanism, capitalism, socialism, and feminism) provides basis for the ideal of restorative community.

The annual lecture will be chaired by Prof. Gabrio Forti, Dean of the Law Faculty and Director of the 'Federico Stella' Centre for Research on Criminal Justice and Policy, Università Cattolica del Sacro Cuore, and introduced by Prof. Ivo Aertsen (Chief Editor of RJIJ). Prof. Gabrio Forti and Prof. Claudia Mazzucato will act as discussants.
